

Pragati & Saksham Scholarship Scheme_2015-16

Instructions for Modification/Changes in Online submitted Application for Pragati & Saksham Scholarship for 2015-16

Candidates admitted in AICTE approved institutions for first year Degree/Diploma in the academic year 2015-16, are eligible to apply for Pragati/Saksham Scholarship as per the provisions of the schemes. Details on eligibility criteria and other relevant information about the schemes will be available at <http://www.aicte-india.org/pragathisakshamscheme.php>.

How to Edit/Surrender the Online submitted Application for Pragati/Saksham Scholarship_2015-16:

1. Login at <http://www.aicte-pragati-saksham-gov.in> with the registered e-mail Id/User name and Password. Click on **Click to Proceed Further**.
2. In case more than ONE application is submitted: Existing Application(s) will be displayed. Application(s) can be verified and after verification, click on **"Surrender Application"** button to surrender the duplicate application. (NOTE: **The surrendered application will not be considered for further processing**).
3. In case application need to be modified/corrected: Existing Application will be displayed. In case any changes need to be done, click on **"Reopen Application"** button and follow the given instructions. (NOTE: **Reopen application is allowed only once**).
4. In case no changes are required please log out without making any changes.
5. In case if you want to modify the application, please follow the steps mentioned below:

- A. Enter personal details under the Tab **"Personal Details"**.
- B. Enter details of family and income under the Tab **"Family & Income Details"**
- C. Enter the details of the Institute in which Admission is taken for first year Degree or Diploma course along with fee paid details under the Tab **"Institute Details"**.
- D. Enter SSC/10th Standard and HSC/12th Standard details under the Tab **"Education Details"**.
- E. Enter the details of the Savings Bank Account under the Tab **"Bank Details"**.
- F. Attach the following Scanned documents under the Tab **"Attachments"**:
 - i. SSC/10th Standard Mark sheet.
 - ii. HSC/12th Standard Mark sheet.
 - iii. Annual Family Income Certificate as per Annexure-I (or) as per the State Government format issued by the Competent Authority of the State Government.
 - iv. Admission letter issued by the Centralized Admission Authority to first year Degree/Diploma courses for the academic year 2015-16.
 - v. Tuition fee paid receipt for the academic year 2015-16. (**Must clearly indicate the word "Tuition Fee"**)
 - vi. Scanned Copy of first page of Bank Pass Book(*Only Saving Bank Account in Candidate name*) clearly indicating the following:
 - a. Name of Account holder (candidate) with Photograph
 - b. Name and Address of the Bank
 - c. IFSC Code of the Bank
 - d. Saving Bank Account Number of the account holder (candidate)
 - vii. Certificate Issued by the Director/Principal/HOD as per Annexure-II
 - viii. Certificate Issued by Competent Authority in case of candidates applying for Saksham Scheme (Only for Physically Disabled Candidates having more than 40% disability) as per the State Government Format.
 - ix. Declaration by Parents as per Annexure - III for Pragati Scheme and as per Annexure - IV for Saksham.
 - x. Aadhaar Card (If Available).
 - xi. Candidate Photograph.
 - xii. Candidate Signature.

6. All regional Language documents should be translated in English and authenticated by Principal/Director of concerned institution
